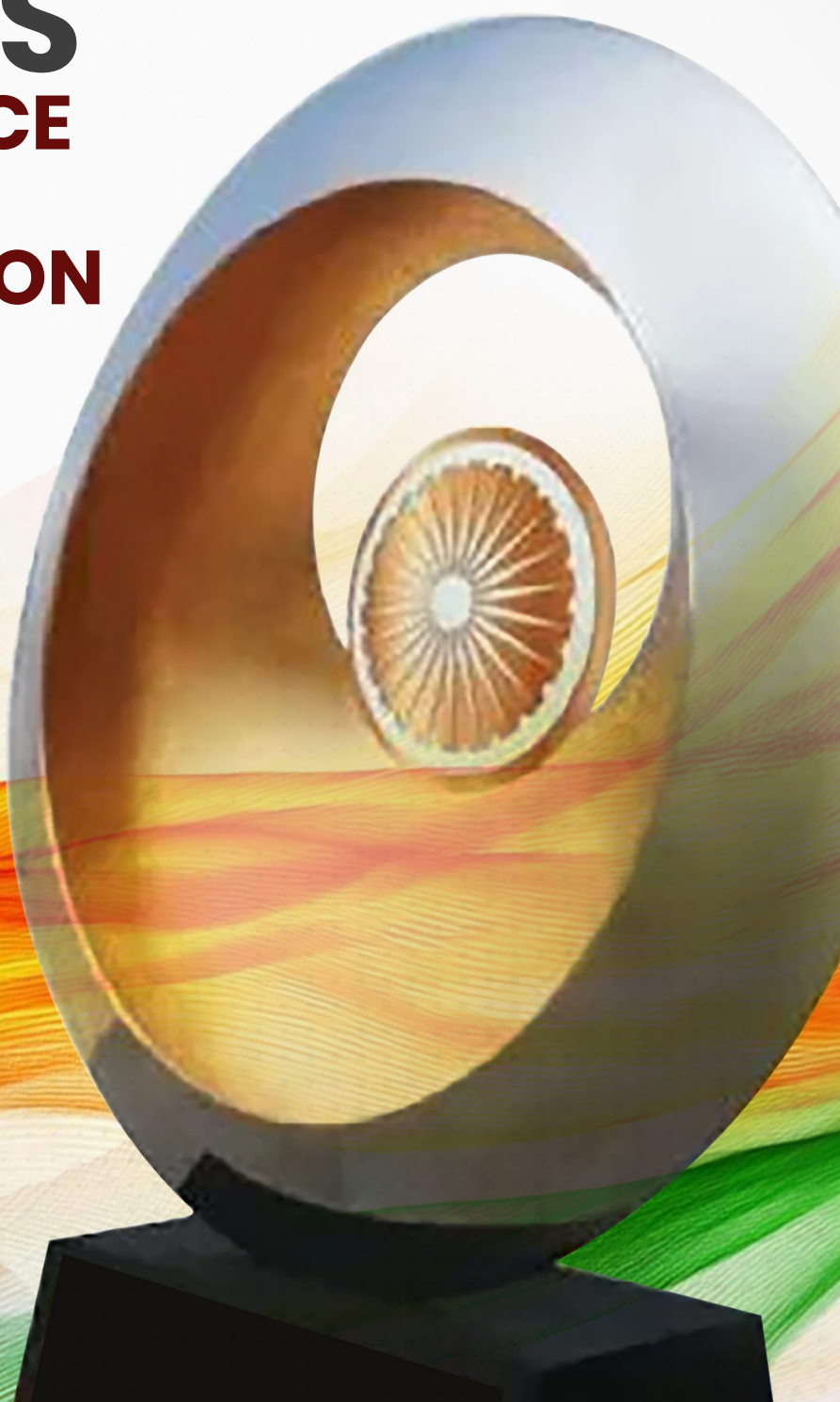

AWARD 1 - INNOVATION (CENTRE) CATEGORY

Face Authentication

Unique Identification Authority of India

The UIDAI Face Authentication system revolutionizes Aadhaar-based identity verification by providing a contactless authentication alternative. It is particularly beneficial for individuals who struggle with traditional biometric methods (fingerprint or iris scans) due to worn-out finger, iris template aging, cataracts, or other issues. Developed by UIDAI using AI/ML technology, this solution ensures the identity of Aadhaar holders through a facial image match, confirmed against the data captured during Aadhaar enrolment. Its integration across multiple government programs, banking, telecoms, and other sectors ensures secure, efficient, and transparent service delivery. It supports Digital Life Certificates, cashless hospitalization, ABHA ID creation, and various welfare schemes, and is compatible with AUA applications and entry-level Android smartphones.

KEY ASPECTS

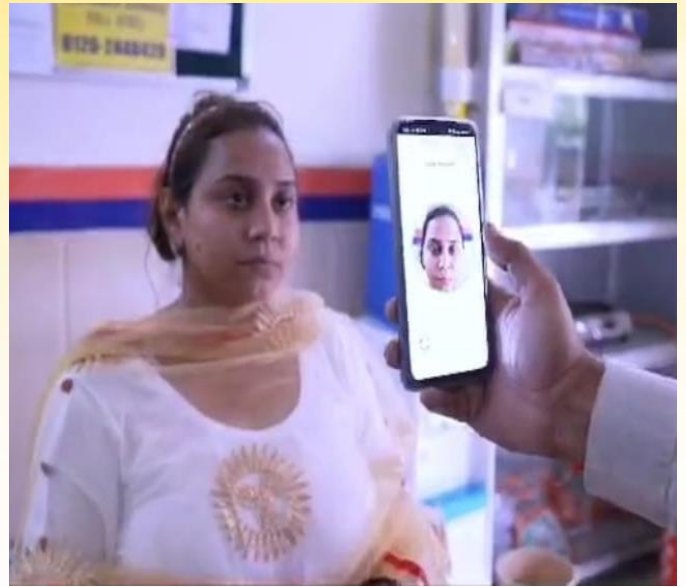
- Face Authentication application can be easily downloaded and used on the Google Play Store and supports both operator-assisted and self-assisted modes on smartphones.
- Application integrates with AUA (Authentication User Agency) applications, facilitating geo-tagging and other services within the AUA framework. This integration ensures widespread usability across various sectors.
- Face Authentication adds a layer of security, reducing fraud and ensuring resources reach their intended recipients.

IMPACT OF THE INITIATIVE

- Over 2.35 million Face Authentication transactions have been conducted by banks and financial institutions, reducing fraud and ensuring resources reach the intended recipients.
- The app has over 1Cr. downloads on the Google Play Store as of March 22, 2024.
- 15 lakh pensioners have successfully generated Digital Life Certificates through Jeevan Pramaan in November 2023 alone.
- Facilitated 37 lakh transactions under PM-Kisan Samman Nidhi since May 2023. Enabled 18 lakh transactions in PMAY (U) since April 2023.
- Lowered administrative costs while enhancing inclusivity by providing reliable identity verification, crucial for welfare schemes, healthcare access, and financial assistance programs.

AWARD 2 - INNOVATION (CENTRE) CATEGORY

PM SVANidhi

Ministry of Housing and Urban Affairs

The PM SVANidhi scheme supports urban street vendors by promoting financial inclusion and digital integration, offering collateral-free loans of up to ₹50,000. It streamlines vendor identification via a Letter of Recommendation (LOR) and employs end-to-end digitization for smooth loan disbursal. Additionally, the scheme connects vendors and their families to eight central welfare programs, providing a robust social safety net. Through the "SVANidhi se Samridhi" initiative, over 38 lakh vendors and their families have benefited, driving socio-economic upliftment. With 45% of beneficiaries being women, the scheme has also reduced reliance on exploitative moneylenders and introduced over 41 lakh vendors into the digital economy.

KEY ASPECTS

- Collateral-Free Microcredit Assistance: Offer loans up to ₹50,000 to urban street vendors, fostering financial inclusion and economic development.
- Streamlined Vendor Identification: Uses a Letter of Recommendation (LOR) to quickly identify vendors, bypassing traditional surveys.
- End-to-End Digitization: Streamlines loan disbursal, enhancing transparency and reducing delays through fully digitized processes.
- Connecting vendors and their families to central welfare schemes, ensuring a social safety net for overall well-being.
- Improves service delivery with a strong grievance redressal system to address vendor concerns effectively.

IMPACT OF THE INITIATIVE

- Over 80 lakh loans total of Rs 10,600 crore have been disbursed to 60 lakh street vendors nationwide.
- 45% of beneficiaries are women, with significant inclusion of marginalized groups, fostering equity and inclusivity.
- Enabled digital transactions worth Rs 2.04 lakh crore, supporting India's digital growth.
- Socio-economic profiling of 28 lakh vendors and families has enabled access to central welfare schemes, benefiting millions.
- Operational in all 36 States and Union Territories, involving local bodies and development authorities nationwide.

AWARD 1 - INNOVATION (STATE) CATEGORY

Cyber Tahsil

Madhya Pradesh

Cyber Tahsil is a cutting-edge initiative aimed at transforming land mutation and updating land records into a paperless, faceless, and online process post-registry. The Innovation's digital system integrates seamlessly with several key portals, including Revenue Case Management System (RCMS), MP-BHU LEKH, SAMPADA (IGRS), and the Smart Mobile Application for Revenue Administration (SAARA). Governed by the Madhya Pradesh Bhu-Rajaswa Sanhita (Cyber Tahsil Ki Prakriya) Niyam, 2022, the initiative significantly enhances efficiency by minimizing human intervention and paperwork.

KEY ASPECTS

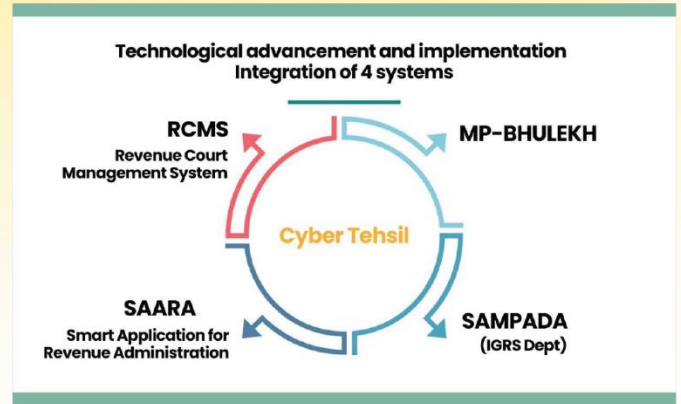
- Introduction of a digital platform reduces the necessity for in-person visits, streamlines document handling, and speeds up the overall process. It simplifies interactions for users and decreases the risk of administrative bottlenecks.
- Innovation provides automated, real-time updates on case status and land records, thus enhancing transparency by allowing users to track the status of their applications in real-time, leading to faster resolutions and increased user satisfaction.
- Cyber Tahsil's automation reduces reliance on manual input and decision-making, minimizing human error thus improving accuracy and efficiency in processing land mutations. With fewer manual steps, the risk of errors is lowered, leading to more reliable and consistent outcomes.
- Designed with scalability in mind, Cyber Tahsil can be adopted by other States and regions, potentially standardizing and modernizing land administration practices across the country.

IMPACT OF THE INITIATIVE

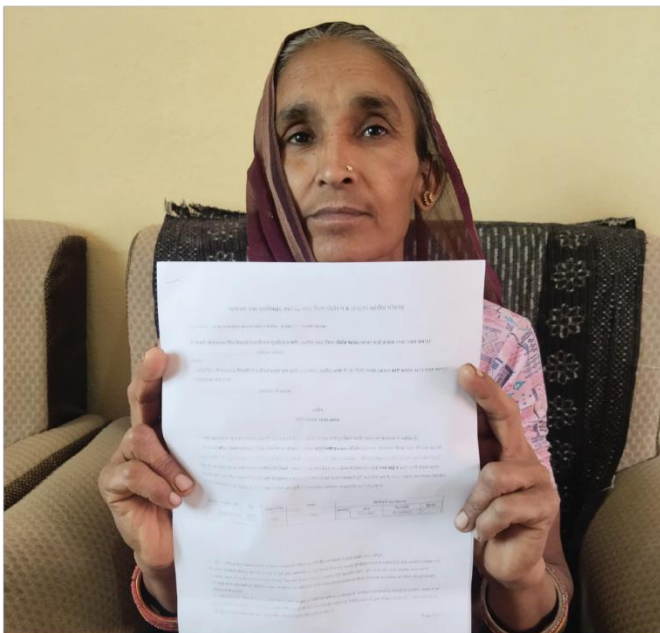
- Average processing time for land mutations has decreased from 30 days to 15-17 days.
- Significant reduction in bureaucratic delays and paperwork, leading to faster service delivery for citizens and local administrations.
- Reduction in administrative burdens, allowing local authorities to focus on other tasks.
- Demonstrates a scalable model with the potential to transform land administration practices across the country.

AWARD 2 - INNOVATION (STATE) CATEGORY

Solar-Powered Water Schemes under the National Jal Jeevan Mission (JJM)

Uttar Pradesh

The Solar-Powered Water Supply Scheme under the Jal Jeevan Mission integrates Solar Energy into Rural drinking water supply systems, with an objective to provide reliable access to safe drinking water in rural areas. The initiative addresses challenges related to electricity supply, maintenance costs, and environmental sustainability by using solar power to operate water pumps and purification systems. The innovation supports off-grid water supply solutions, reduces carbon emissions, and contributes to India's goal of achieving "Net Zero Emissions by 2070".

KEY ASPECTS

- **Cost-Effective Solution:** Solar-based systems eliminate high costs associated with traditional fuel or electricity, leading to long-term savings on operation and maintenance.
- **Environmental Sustainability:** Solar energy systems contribute to reducing carbon footprints, mitigating coal reserve depletion, and addressing environmental concerns.
- **Operational Reliability:** Solar-powered systems ensure consistent water supply in sunny conditions and are less affected by power outages.
- **SCADA & Automation:** SCADA & automation systems has been established in all the water supply schemes to enhance efficiency and sustainability in water supply by real time monitoring dashboard.
- **Training programs** have been conducted for around 12.36 lakh individuals, including women, for water quality testing and system maintenance.

IMPACT OF THE INITIATIVE

- Reduces annual CO2 emissions by 13 lakh metric tons, with potential revenue of INR 624 crore from carbon credit sales.
- The project reduces dependence on conventional power, conserves coal, and addresses hydro and nuclear energy limitations.
- Of 33,157 planned schemes, 22,425 have been implemented, benefitting 2.07 crore households and 13.3 crore people, and trained 12.36 lakh locals in solar system maintenance and operations.

AWARD 1- INNOVATION (DISTRICT) CATEGORY

GIS-based Water Conservation Plan for Dhamtari District

Dhamtari, Chhattisgarh

The GIS-based Water-Conservation Plan in Dhamtari, developed under the Jal Shakti Abhiyan, "Catch the Rain" initiative, aims at addressing water management challenges in the region. This innovation focuses on maximizing rainwater harvesting, Geo-tagging, creating an inventory of existing water harvesting structures, and preparing a scientific plan for their conservation. The initiative utilizes an interactive web application to address water scarcity and promote sustainable agriculture through rainwater harvesting and scientific conservation planning. By leveraging remote sensing data and advanced Geo-spatial technologies such as QGIS, ArcGIS, and Google Imagery, it has geo-tagged and mapped 1,740 water bodies in the district using ISRO/Bhuvan images. This effort has resulted in a comprehensive water body census and a strategic water conservation plan.

KEY ASPECTS

- Utilizes GIS tools like QGIS, ArcGIS, and Google Imagery to create detailed, interactive maps that guide water conservation activities.
- Combines geological and hydrological data to facilitate informed decision-making, improving the efficiency and effectiveness of water conservation efforts.
- The web application is publicly accessible, empowering citizens to participate in water management decisions and activities.
- The model is easily customizable for other districts using open-source data from ISRO/Bhuvan portal, making it a versatile solution for water resource management.

IMPACT OF THE INITIATIVE

- Identified and geo-tagged 1,740 water bodies in the district, and completed 239 out of 369 proposed water conservation structures and 2,353 out of 3,683 proposed renovations of traditional and other water bodies.
- Completed 504 out of 1,256 reuse and recharge structures, 2,603 out of 3,157 watershed development projects, and 423 out of 605 afforestation initiatives.
- Rainwater Harvesting Structures (RWHS) implemented in 834 urban buildings, with 238 more under construction.



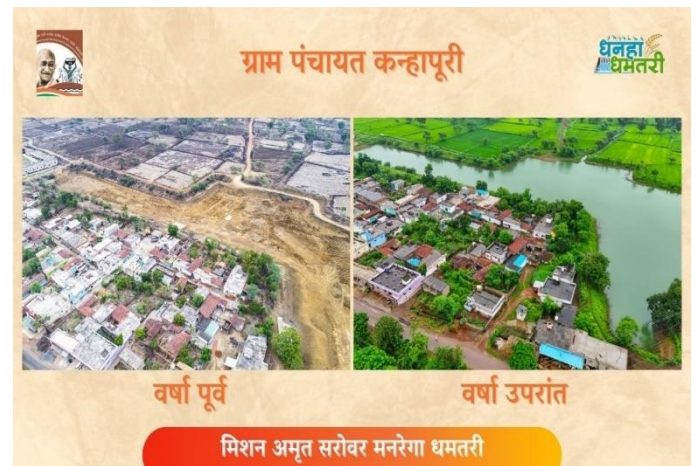

AWARD 2- INNOVATION (DISTRICT) CATEGORY

PRISM 10

Parvathipuram Manyam, Andhra Pradesh

PRISM 10, an innovative health initiative, launched in Parvathipuram Manyam an aspirational tribal district with a significant PVTG population aims at significantly reducing the Infant Mortality Rate (IMR) below 10. The innovation addresses critical healthcare challenges, including Anemia, High Maternal Mortality, and Low Immunization coverage. Through a multi-faceted approach, PRISM 10 focuses on early pregnancy registration, comprehensive maternal and child health monitoring, and community engagement through Self-Help Groups (SHGs). With an aim to ensure early and regular healthcare interventions, such as antenatal care (ANC), anaemia management and family planning, the initiative employs a combination of door-to-door visits, mobile medical units, telemedicine, and community-driven programs to enhance maternal and child health outcomes in the district.

KEY ASPECTS

- Emphasized early pregnancy registration through SHG-led outreach and ensured regular monitoring of Mother and Child registrations at sub-centres for adherence to health protocols and timely interventions.
- Implemented mandatory Hb tests and three ANC check-ups for pregnant women, and established Anaemia Action Committees at the Tehsil level for managing anaemia through home and Anganwadi visits.
- Conducted special family planning camps, set up hostels for pregnant women from remote areas, and used mobile medical units and telemedicine for regular and remote healthcare.

IMPACT OF THE INITIATIVE

- Reduced IMR (Infant Mortality Rate) from 24 to 8, increased ANC (Antenatal Care) coverage from under 50% to over 91%, boosted PNC (Postnatal Care) coverage from below 60% to over 90%, lowered MMR (Maternal Mortality Ratio) from 128 to 74, and surged immunization rates for infants and children from below 48% to 97.7%.
- Focused on PVTGs (Particularly Vulnerable Tribal Groups) like Savara and Gadaba in Parvathipuram Manyam, leveraging 19,726 SHG groups to drive community involvement and health education.
- Implemented across 2,200 habitations in the district, characterized by challenging terrain and dispersed populations.

- The performance of the districts has been evaluated in a cumulative manner. The Scheme encouraged last mile delivery, saturation approach and citizen centricity.
- District Collectors presented a comprehensive picture of the progress achieved across 12 schemes and their leadership role over the implementation period in the nomination form.

AWARD 1 - HOLISTIC CATEGORY

Barpeta, Assam

KEY ASPECTS OF THE DISTRICT

Barpeta district situated in Assam, has been honored with the Prime Minister's Awards for Excellence in Public Administration 2023, recognizing its exceptional performance in the 'Holistic Development of Districts' category.

Among the 12 government flagship schemes assessed, the district has achieved over 90% saturation in four schemes: Pradhan Mantri Awas Yojana-Urban (PMAY-U), PM SVANidhi, Pradhan Mantri Matru Vandana Yojana (PMMVY), and Mission Indradhanush. These schemes have been instrumental in improving housing for urban residents, supporting street vendors, promoting maternal health and enhancing immunization efforts.

The Pradhan Mantri Awas Yojana-Gramin (PMAY-G) scheme, aimed at providing housing in rural areas, has been awarded more than 80 marks out of 100. This reflects the district's effective execution of the scheme, demonstrating its commitment to improving rural housing and living conditions.



IMPACT OF THE INITIATIVE:

- Systemic interventions were implemented for transparency, including multilevel checking, technology use like e-Office and e-Bill modules, and action against corruption with 272 FIRs lodged and 18 contracts cancelled under JJM.
- The district has empowered Self-Help Groups (SHGs) with a significant increase in turnover from ₹405 Crores to ₹706 Crores, showcasing a growth of 74.3%.
- 200 Jal Doots were deployed across the district to enhance public participation and awareness for Jal Jeevan Mission. Their efforts successfully engaged the wider community, ensuring active involvement in water conservation and management initiatives.
- The district has effectively converged multiple government schemes to enhance governance and infrastructure development, leading to the establishment of 167 Anganwadi Centres (AWCs) and the construction of 7.967 kilometers of roads. These initiatives have significantly improved local infrastructure.
- The district conducted quarterly SAMADHAN camps in 98 Gram Panchayats to address public grievances efficiently, fostering community trust and engagement. This proactive approach contributed to the district's top ranking in PM POSHAN MAAH 2023, recognizing its exceptional efforts in improving child nutrition.
- Implemented "Sampoorn Ghar" initiative alongside PMAY-G wherein 68,639 rural households have been provided with essential services such as gas connections, JJM water supply, toilets, electricity, PM-JAY cards, significantly improving their standard of living.
- The district has achieved 100% target completion under PM SVANidhi scheme, significantly boosting the economic activity of street vendors and small shop owners. It has enabled beneficiaries to expand their businesses while providing easy access to collateral-free loans, thereby promoting financial inclusion.

AWARD 2 - HOLISTIC CATEGORY

Kulgam, Jammu & Kashmir

KEY ASPECTS OF THE DISTRICT

Kulgam district, renowned for its rich cultural heritage and stunning natural landscapes, has showcased remarkable progress through its implementation of twelve flagship government schemes. Among these, the district has achieved over 90% saturation in three crucial initiatives: the Pradhan Mantri Awas Yojana-Urban (PMAY-U), PM SVANidhi, and Mission Indradhanush.

The successful execution of PMAY-U has significantly improved urban housing conditions, providing much-needed shelter to the urban poor. Meanwhile, PM SVANidhi has played a vital role in supporting street vendors, helping them gain access to financial resources that enhance their livelihoods. Additionally, Mission Indradhanush has strengthened immunization efforts in the region, contributing to the overall health and well-being of the community.

In the rural sector, Kulgam has also made notable strides with the Pradhan Mantri Awas Yojana-Gramin (PMAY-G). This scheme, which focuses on providing adequate housing for rural populations, received an impressive score of 84 out of 100 from nodal ministries. This high rating reflects the district's effective execution of the program, highlighting its commitment to improving housing solutions for rural communities.

Overall, Kulgam's accomplishments illustrate a comprehensive approach to development, where various schemes are harmoniously integrated to enhance the quality of life for its residents.

- **Employment & Skilling:** Full implementation of PM SVANidhi, PM Vishvakarma, and MUDRA Yojana, in convergence with self-employment and skilling programs, has promoted youth empowerment and economic self-reliance.
- **Infrastructure Development:** Created 210 playgrounds, roads, libraries, and solid waste disposal sites across the district, with a focus on reclaiming encroached land and building durable community assets.
- **Governance & Transparency:** Digitized governance systems, online grievance redressal portals, and active monitoring through the *Rehbar-e-Kulgam* IT portal have enhanced transparency, reduced corruption and ensured timely service delivery.
- **Sustainability & Replicability:** District's initiatives, such as door-to-door scheme registrations, digital interventions, and social media-driven awareness campaigns have been institutionalized, contributing to long-term development.

AWARD 3 - HOLISTIC CATEGORY

Eluru, Andhra Pradesh

KEY ASPECTS OF THE DISTRICT

Eluru, a coastal region of Andhra Pradesh, has been recognized for its administrative excellence under the Prime Minister's Awards for Excellence in Public Administration 2023 in the 'Holistic Development of Districts' category. Among the 12 flagship schemes assessed, the district has achieved 100% saturation in Pradhan Mantri Matru Vandana Yojana (PMMVY), Pradhan Mantri Awas Yojana-Urban (PMAY-U), and Pradhan Mantri Jan Arogya Yojana (PM-JAY), highlighting the district's success in ensuring extensive coverage and tangible outcomes. These schemes include each playing a crucial role in improving maternal health, providing affordable housing, and enhancing access to healthcare.

The district has achieved an impressive score of 85.68 out of 100 for Pradhan Mantri Ujjwala Yojana (PMUY), aimed at providing LPG connections to women from Below Poverty Line (BPL) households. This highlights the district's effective implementation of the scheme and its dedication to ensuring clean cooking fuel access for rural households, improving health and reducing the dependency on traditional fuels like firewood.



IMPACT OF THE INITIATIVE:

- The district administration has introduced several measures to promote transparency and combat corruption through the *Har Ghar Jal Yojana* and *Pradhan Mantri Awas Yojana* (PMAY). Har Ghar Jal Yojana ensured financial transparency by maintaining separate bank accounts and conducting social audits, allowing for better tracking of funds and accountability. Meanwhile, PM Awas Yojana offered online access to beneficiary lists and provided toll-free complaint numbers, empowering citizens to report issues, thereby reducing the potential for corruption and enhancing trust in the system.
- Regular weekly reviews and third-party inspections have ensured that schemes are implemented effectively and meet quality standards.
- Constructed 98,874 houses on a large scale in the district, improving the economic development of the district. The construction of houses directly and indirectly increased wage and skill employment in the district.
- Trained field workers under schemes like Har Ghar Jal and PM Poshan have ensured high-quality implementation and service delivery.
- The Jaganannaku Chebudam program streamlined grievance redressal by facilitating weekly sessions at various administrative levels, ensuring swift resolution of citizen complaints. This structured approach allowed for effective communication between the public and authorities, leading to timely responses and enhanced public trust in the system's ability to address concerns efficiently.
- Birth planning for high-risk pregnant women has been prioritized, and Jan Aarogya Samitis and Rogi Kalyan Samitis have been established. These committees hold regular meetings to ensure social accountability at AB-HWCs and PHCs, working in coordination with VHSNCs to oversee health-related activities.
- Initiatives such as rainwater harvesting and groundwater recharge under Har Ghar Jal Yojana are part of a broader strategy for long-term sustainability and replication of successful models.

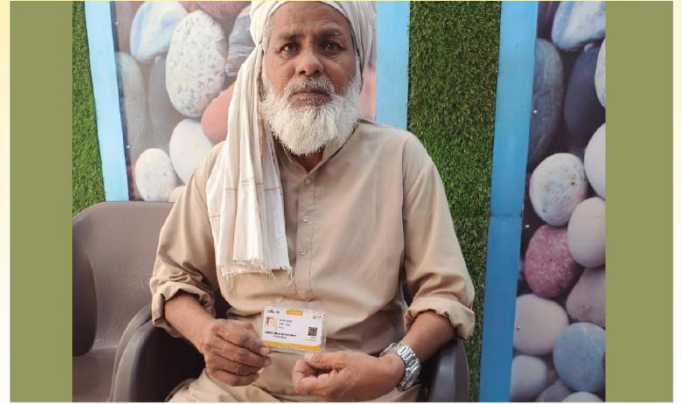

Gumla, Jharkhand

KEY ASPECTS OF THE DISTRICT

Gumla, the second largest district in Jharkhand, spans an area of 5,327 square kilometers and is predominantly inhabited by a tribal population, with approximately 69% of its residents belonging to Scheduled Tribes. Located in the southern part of the Chhotanagpur plateau, it is characterized by its rich cultural heritage and unique ecological landscape. However, the district has long been affected by Naxal violence, which has posed significant challenges to its development and stability.

Despite these obstacles, Gumla has made notable strides in improving housing conditions for its residents. The district has achieved over 90% saturation under the Pradhan Mantri Awas Yojana-Urban (PMAY-U), a program aimed at enhancing urban housing for marginalized populations. This achievement signifies a substantial improvement in the availability of dignified housing options, thereby contributing to the overall quality of life for urban dwellers.

In the rural sector, Gumla has excelled under the Pradhan Mantri Awas Yojana-Gramin (PMAY-G), earning an impressive score of 100. This remarkable accomplishment underscores the district's effective implementation of rural housing initiatives, demonstrating a strong commitment to providing safe and secure homes for the rural population. The success of PMAY-G highlights the administration's focus on addressing housing shortages and improving living standards in rural communities.

Overall, these advancements reflect Gumla's dedication to overcoming its historical challenges and enhancing the welfare of its residents through effective governance and targeted developmental programs. The district's achievements in housing not only foster a sense of security and dignity among its inhabitants but also lay the groundwork for sustainable growth and development in the region.



IMPACT OF THE INITIATIVE:

This initiative has reduced project delays by 77% and increased average monthly expenditure by over 200% in the past year. Over ₹72 lakh have been recovered from officials in civil works due to lifecycle monitoring.
- District has adopted a convergence strategy to address resource constraints by integrating government schemes, CSR funds, and human resources in health and education. Key initiatives include building 50 classrooms, a science center, 50 carbon-neutral villages via solar micro-grids, and libraries at all levels.
- Gumla has placed citizens at the core of its initiatives, introducing E-Jan Shikayat and the Sarvoday portal for grievance redressal, minimizing travel and opportunity costs for residents. Over 1,200 grievances have been received, with more than 60% resolved. Additionally, a dedicated PVTG helpline, managed by the Jharkhand Tribal Development Society, addresses the unique needs of vulnerable groups, enhancing the implementation of PM-JANMAN through inter-departmental collaboration.

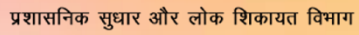
